Dear LREC participants,

We are proud to welcome you in Marrakech, where we are pleased to contribute to the organization of this sixth edition of the Language Resources and Evaluation Conference, LREC 2008. We are very happy to continue the organization of such a major conference for the Human Language Technology community in such a wonderful city.

Let me take this opportunity to thank Mr. A. Reda Chami, Minister of Trade, Industry and New technologies for his support and ask Dr. Taïb Debbagh to convey our best wishes. I would like to thank Mr. Leonard Orban, the European Commissioner for multilingualism, and his representative today Mr. Jochen Richter for his participation. I would like to thank Mr. Ahmed Lakhfir the Moroccan Secretary of State for the Foreign Affairs and Cooperation for his strong support, and Mr. Mounir Chraïbi, Wali of Marrakech, though he can not be with us today, for his continuous support and friendly help. I would like to express particular thanks to his excellence Fathallah Sejilmassi, the Moroccan Ambassador in France and his team (in particular Khalid Afkir) for his strong commitment and dedication.

I would also like to extend our warm thanks to our Moroccan colleagues from the Local Advisory Committee; you may have seen that several ministries, most of the Moroccan universities and institutions are contributing to the success of LREC2008. I can not forget that this year we celebrate the 10th anniversary of LREC, some of you may remember how things started ten years ago in Granada (LREC 1998) with Antonio Zampolli and Angel Martin-Municio, I would like to say how much we owe them today.

The emergence of the Web has largely contributed to promote the sharing of language resources but also, like everything else around the web, it has made it critical to excavate about the nature and the quality of what one gets on the web and the various implications related to such availability (quality, rights and licensing, re-use and exploitation,...). Let me mention just one issue that will be largely debated in this conference: the legal aspect. A survey of the existing licensing schemes recently conducted by ELDA showed that there are more than ten license models, several of them backed up by large institutions, and which handle similar, or even identical, legal matters. Several of them are derived from the software industry traditions and simply transposed to Language Resources. Such abundance and

proliferation, instead of helping users to better understand their rights, duties, responsibilities, and liabilities, are confusing most of them who are not prepared to invest time and money in legal advises. Other aspects will also be discussed that may have a substantial impact on the next decade of Language Resources and Evaluation. The proliferation of resources will also be of major importance in our field. It is becoming natural to search the web for the latest dictionary, corpus, list of words, broadcast recordings, etc, free of charge and copyright free. One may identify a large number of such items for a given language. In many cases, there are serious doubts about the quality but also about the origin as well as the actual right owners. It is a challenge for Data Centers like ELRA, LDC, GSK, Chinese-LDC, and similar agencies, to ensure that such trend is fully supported and streamlined for the benefits of all.
